She concludes by stating that the oppositions of the Member States are strong, so the decision of the European Committee of Social right on the merit are outstanding despite the obvious. She asks for the support of the NFAs to increase awareness on this topics and this in turn will improve their public profile within the community.

- 5. Report Treasurer



Edith gives some words from EWL meeting about Annelies, the beginning of this month, she has been reelected as Treasurer and is asked to give us a report (to be put on the website).

We decreased our deficit from 2768 EUR in 2016 to 422 EUR in 2017, we have a positive result for the account this year after the proposal to further decrease the costs of the Board in 2017. The proposal to use the membership numbers of the previous year for calculating the fee works very well.

The Board propose to keep the membership fee one euro/member. We increase our income getting back other members. Total income: 5605 EUR Deficit: 421 EUR, see here the UWE Balance sheet 2017.

The Board ask the General Assembly to formally approve 2017 final accounts and discharge the board for 2017 accounts.

Question raised: Why we are still in Finland with the bank? Due to personal circumstances, the work with the constitution translation the Treasurer in charge couldn't finalise the procedure with the ING Bank in Amsterdam.

With Treasurer abstain the account is approved.

UWE Budget 2017-2018 has been approved

UWE membership 2018 approved also

Discharge the Board for the responsabilities – agreed

6. Israel's request to join UWE:



In 2017 as the Constitution did not allow them to join without a change of the constitution there was a proposal to look into constitutional options. The Constitutional Committee concludes that under the current constitution there was such no possibility therefore an alternative proposal was accepted.

A Memorandum of Understanding - MOU (agreement allowing CER attendance not just observer status) produced by the Constitutional Committee ultimately 15 of September will be circulated to the CER network for agreement and or amendments and comments ultimately at the end of October. This may facilitate discussion within the countries. This agreement and any comments will allow the constitutional committee to compile a discussion paper outlining options by half of December 2018 for full discussion and responses from countries by 1st of March, 2019. The Board will then decide if any resolutions to put forward to the next AGM and GWI meeting, 2019.

Edith asks to vote the ammendments first: the current draft will be considered, after it will be sent to the CERs until the mid of September. The vote goes unanimously in favour for timeline to including the possibilities.

7. NEXT AGM and MEET AND GREET

France proposed to organise in 2020 an event (more information from Marie Claire). A proposal will come from Scotland by the end of summer to organise a Meet and Greet. The next AGM in 2019 will be a short one and will be held during the 33rd Triennial GWI Meeting in Geneva.
